



### **Corowa Rotary Federation Market (the Market) – Stall Terms and Conditions**

The Market is held at Bangerang Park, Corowa on the first Sunday of each month and on such other days as advised to all stallholders via a yearly timetable. The timetable will be provided to the stallholders by June in each year.

#### **By occupying a site each stallholder agrees:**

1. They are responsible for the condition and fit for purpose of all goods offered for sale and sold by the stallholder and the terms and conditions of sale.
2. To indemnify the Corowa Rotary Club (Rotary) and Federation Council against any claim/s for damages and/or injury to any person or property arising as a result of negligence on the part of the stallholder or their agents or servants.
3. That to the full extent permitted by law, Rotary and its agents disclaims all liability for any loss or damage arising at or from the operation of the Market.
4. To comply with all Local, State and Federal By-laws, Regulations, Acts or Statutes relevant to the stallholder's products and the Market and to comply with all reasonable directions from a Rotary officer and comply with all Market rules advised by Rotary to the stallholder.
5. Any stallholder who sells food must comply with the NSW Food Authority Regulations and must complete and submit a Food Business Notification. This form can be completed online form by going to [www.foodnotify.nsw.gov.au](http://www.foodnotify.nsw.gov.au) and complete the "notify food business details" form. Evidence of notification must be provided to Rotary upon request.
6. That no firearms, ammunition, prohibited or dangerous goods will be offered or displayed for sale.
7. To be responsible for the stallholder's property, including motor vehicles and trailers on market day and the stallholder acknowledges that Rotary will not be liable to the stallholder in any respect for the theft of or damage to the stallholder's property while at the Market.
8. To display and sell only those products nominated when booking a site unless approved by the Rotary officer on the day of Market.
9. To confirm or cancel a booking or notify Rotary of a late arrival by close of business on the Wednesday prior to each Market by telephone to 0490 126 311
10. The Market commences at 8.30 am and continues until 2.00pm. The stallholder must be set up by no later than 8.00 am and must not cease trading before 1.00pm unless sold out of product or otherwise approved by Rotary on the day. Sites not occupied by 8.30a.m., may be re-allocated and any fee paid by the stallholder forfeited.
11. To accept the site allocated and respect the rights of all other stallholders. Sites are subject to availability at each Market and Rotary does not guarantee future availability.
12. To operate the stall within the site boundaries. The stallholder's motor vehicles are to be parked outside the Market area.
13. The stallholders must provide evidence of public liability insurance in a sum not less than \$10,000,000.00 for any single event by way of a Certificate of Currency of insurance. If the

- stallholder does not have its own insurance it must pay Rotary for appropriate insurance on each Market day. The cost of insurance will be advised to each stallholder when a site is booked.
14. To pay all site fees and insurance costs if required on the day of Market by way of cash. .
  15. To remove all unsold product and rubbish from the Market grounds by no later than 3.00pm on the day of Market
  16. To abide by the decision of a Rotary officer in relation to all issues/disputes arising on the day of Market. The stall holder shall have the right to appeal to the Rotary Board after the Market Day to resolve any issues unresolved on the day. The decision of the Rotary Board shall be final and binding
  17. All electrical cables must be tag tested on a regular basis and when in use at the Market must be placed in such a manner that no risk is posed to the public..
  18. That the Market will run regardless of weather unless notified otherwise to each stallholder on the morning of Market.
  19. That Rotary reserves the right to refuse admission to the Market to any person or persons without giving any reason and to eject or cause to be ejected any person or persons and/or their goods and chattels without giving any reason.
